## Dr. Lukacs,

The Agency is currently conducting an inquiry pursuant to section 81 of the Canada Tr ansportation Act (CTA) where the matter to be determined is whether NewLeaf is requir ed to hold a licence under the CTA. The Agency is conducting this inquiry in its capa city as an economic regulator and not as a quasi-judicial tribunal such that the Cana dian Transportation Agency Rules (Dispute Proceedings and Certain Rules Applicable to All Proceedings) (also known as the Dispute Adjudication Rules) do not apply. The Pa nel assigned to the NewLeaf licencing activity has decided to treat the correspondenc e as information which the Agency may consider as it conducts its inquiry into whethe r NewLeaf will require a licence. This decision of the Panel is being prepared and wi ll be made available to you once it is issued.

Given that this is an economic regulatory matter, the documents are available to you under the Access to Information Act (ATIA). While the Agency's practice is to readily release information on an informal basis in the spirit of openness and transparency, in this particular case and given that:

- it is third party information for which the Agency must consult with the originator s of the documents; and,

- there is a claim for confidentiality with respect to one of the documents which wil l need to be assessed pursuant to the provisions of ATIA;
