Re: Dr. Gabor Lukacs v. Canadian Transportation Agency and NewLeaf Travel Company Inc. (Proposed Appeal No. 16-A-17)

I am writing to advise that our firm has been retained by NewLeaf Travel Company Inc. ("NewLeaf") in connection with the above referenced matter.

I am writing, at the advice of the Federal Court of Appeal Registry Office, to indicate that we take issue with the date of effective service noted in the Affidavit of Service filed by Dr. Lukacs.

I recently spoke with Stephen Green of the Federal Court of Appeal Registry Office and he indicated that April 19, 2016 showed as the date of service in Dr. Lukacs Affidavit of Service. Mr. Green was also kind enough to indicate that April 19, 2016 was the date upon which Dr. Lukacs sent the Motion Record via courier but not actually the date the Motion Record was received.

We believe the effective date of service should be April 25, 2016 which is the date our office, which is the registered office for NewLeaf, received the package via courier. Our office maintains a ledger for when packages are received via courier. I have attached the ledger for April 25, 2016 showing that the package from Dr. Lukacs was received on that date.

Consequently, we would submit that the twenty (20) time limit for our responding materials should actually be May 16, 2016, given that May 15, 2016 is a Sunday. I would ask that the file for this matter remains at the Registry Office until that time so that our responding materials can be properly added to the file.
